







Location

Waterfront Leisure has direct access. from the A518 which forms part of the inner ring road. The scheme comprises part of a multi million pound regeneration project and provides a new retail and leisure destination for the town centre.

Stoke on Trent lies 16 miles to the north and Cannock 12 miles to the south along the A34. The M6 motorway runs North to South past the town.

There is a catchment of 192,000 people within a 30 minute drive time with both Affluent Achievers and Social Group C1 being represented well above the national average.

Scheme
